



Regular Rate

12.50 per night per guinea pig.

Extended Stays*

30-59 nights: 10% off of total bill

Over 60 days: 25% off total bill

(*For stays 30 days or longer, we require the first 30 days' payment upon drop-off.)

Multiple Guinea Pig Discount

If you have four or more guinea pigs in the same cage, you will receive a 10% discount off your entire bill. This will be eligible to be combined with the extended stay discount.

Medical Boarding*

\$25 daily per medical guinea pig (medical boarding cannot be discounted).

Fluid Administration, prescription administration, syringe-feeding, etc. during stay.

*Prescriptions and instructions for administration from your vet must be provided upon drop-off.

WHAT'S INCLUDED:

Food - included during their stay. Feedings are done twice daily.

- **Morning feedings** are for hay, pellet refill and freshening up the water bottles.
- **Evening feedings** consist of fresh hay and a salad of 2-3 different veggies and occasionally some fruits.

Housing - Private 8-square foot cage or larger (if available) on kiln-dried pine pellets. Fleece for skinny pigs, or upon request.

Cleaning- Weekly cage cleaning top to bottom.

Health Checks - incoming health checks are FREE and part of the boarding.

100% of boarding proceeds goes directly to the overall care of the piggies!

Boarding Agreement

- 1) Owner certifies the accuracy of all information conveyed about the owner's pet(s) to Juniper's .
- 2) Owner authorizes the Facility to obtain medical records for the pet(s) listed above from the veterinarian listed above if needed. Owner further authorizes said veterinarian to provide these records to the Facility.
- 3) Owner agrees not to bring pet(s) to Facility if pet(s) exhibit any signs of illness that may be harmful to the other pets in attendance, such as: vomiting, diarrhea, coughing, extreme lethargy, etc. without first obtaining approval from the Facility.
- 4) Facility shall exercise reasonable care for the owner's pet(s) while it/they is/are in the Facility's custody. The owner recognizes the potential risks (such as illness and/or injury) involved with boarding and grooming.
- 5) Facility may change the level or type of boarding or possibly remove the pet(s) optional services, if Facility believes it necessary to ensure the safety of the owner's pet(s), other pets or its volunteers.
- 6) Owner represents to the Facility that the owner is over 18 years of age; that all information provided about the owner is accurate; and that all credit card information provided is accurate.
- 7) Owner agrees to the Policies and Procedures posted on its website on check-in date. The Facility reserves the right to adjust said Policies and Procedures without prior notice.
- 8) Owner gives the Facility consent to act on the owner's behalf to obtain veterinarian services if owner's pet(s) become(s) ill or require(s) the attention of a veterinarian. The owner agrees that the Facility, in its sole discretion, may engage veterinarian services, administer medicine, or give other requisite attention to the pet(s); that all expenses incurred shall be paid by the owner; and agrees to indemnify and hold the Facility and its volunteers harmless from said expenses.
- 9) Owner agrees to pay all charges incurred for: special services requested veterinary costs as stated above, and failure to comply with the Facility's Cancellation Policy.
- 10) Facility shall have the right to refuse to release the owner's pet(s) until the owner has paid all charges due to the Facility. The Facility is hereby granted a lien on the owner's pet(s) for any and all unpaid charges resulting from boarding or any other service provided by the Facility.
- 11) Owner assumes any and all liability and expenses for injuries inflicted upon any human or other pet(s) by the owner's pet(s) while in the Facility. Owner agrees to indemnify and hold the Facility and its volunteers harmless from any and all liability and expenses incurred as a result of said injuries.
- 12) Facility has the right to take photographs and/or videos of the owner's pet(s) while in the Facility's care. The Facility may post or reproduce any and all photographs/videos taken (as well as pet(s) name) on or in, without limitation, the Facility's website, social media sites or promotional materials without becoming liable to the owner (or the owner's pet(s)) for any royalty payment. Owner hereby releases, covenants not to sue, and forever discharges the facility of and from any and all claims, demands, rights, and causes of action of whatever kind or nature. Further, the owner agrees that no photography or video may be taken by the owner while in the Facility without written approval from the Director.
- 13) Owner agrees that the Facility's liability shall not exceed the current chattel value of a pet of the same species delivered to the Facility.
- 14) This Agreement contains the entire agreement between the parties and shall be binding on the heirs, administrators, personal representatives and assigns of the owner and the Facility.

15) Owner releases, indemnifies and holds the Facility harmless from any and all manner of damages, claims, losses, liabilities, costs or expenses, causes of action or suits, whatsoever in law or equity (including, without limitation, attorney's fees and related costs) arising out of or related to the services provided by the Facility, except which may arise from the sole gross negligence or intentional and willful misconduct of the Facility, including, without limitation:

- 1) Any inaccuracy in any statement made by owner or information provided by owner to the Facility;
- 2) Your pet(s), including but not limited to destruction of property, pet bites and transmission of disease;
- 3) Any action by the owner which is in breach of the terms and conditions of this Agreement.

16) Any controversy or claim relating to this Agreement shall be settled by arbitration in accordance with the rules of the American Arbitration Association. Judgment upon the award rendered by an arbitrator may be entered in any court having jurisdiction thereof. The arbitrator shall, as part of his/her award, determine an award to the prevailing party of the costs of such arbitration and reasonable attorney's fees of the prevailing party.
